### **Position Overview**

Pew seeks to hire a senior associate whose data and research focus is centered on state and local juvenile justice systems. The ideal candidate has an educational and employment background in public policy, criminology, or a related field; knowledge of juvenile justice systems; experience conducting research with state, local, or federal justice system data; experience working with state corrections or juvenile data; and work experience undertaking projects involving multiple partners, extensive writing, and presentation.

This position, based in Pew's Washington, DC, office, reports to the manager, juvenile justice research, and has a set time frame that could be extended based on the success of the program, funding sources, and board decisions on continued support.

## Responsibilities

Under the direction of the juvenile justice research manager and in consultation with colleagues across Pew, the senior associate is responsible for:

- Working with project staff to identify the most salient issues for the project's research
  agenda. Based on that agenda, collaborating to develop, write, and edit research reports,
  briefs, and data visualizations that are rigorous and accessible to policy makers and the
  public.
- Working with project staff to identify policy trends and opportunities, develop initiatives, and advance data-driven, research-based reforms to juvenile systems.

- Conducting descriptive analyses of placement, court, child welfare, behavioral health, and education data; preparing reports; and delivering presentations. This includes preparing data for analysis and working with state and local partners to ensure accuracy in analysis and interpretation.
- Maintaining knowledge of juvenile justice policy research, data sources and practice, and synthesizing such information for project staff.
- Reviewing documents for PSPP staff engaged in technical assistance for content and accuracy.
- Ensuring that all data, reports, presentations and other materials adhere to the highest level of methodological rigor, have been verified in consultation with state officials, and comply with all rules and regulations regarding personally identifiable information.
- Developing briefs, factsheets, infographics, and other documents that are highly relevant to policy deliberations and easily digested by policy makers, media, and the public.
- Contributing to and participating in other tasks of the project, as well as broader Pew projects and activities, as assigned.

## **Qualifications**

- Bachelor's degree required; advanced degree preferred.
- The ideal candidate possesses strong quantitative skills and proficiency with statistical software packages such as SPSS, SAS, STATA, and/or R.
- At least four years of applicable experience in criminal or juvenile justice research and policy analysis or a relevant field, with demonstrated understanding of at least one of the following areas: juvenile probation, juvenile dispositions, risk and needs assessment, racial and ethnic disparities in the justice system, courts, law enforcement, education pathways to juvenile justice, diversion, prosecution, or criminal defense.
- Familiarity with state juvenile justice or sentencing and corrections data, or experience working with other large data sets and sources.
- Experience working directly with policy makers, executive agency officials, researchers, and other justice system stakeholders is strongly preferred.
- Ability to express ideas, thoughts, and concepts clearly and concisely in a compelling way, both in writing and oral presentation.
- Demonstrated time- and project-management skills, including an ability to meet multiple deadlines by maintaining a high level of organization. Ability to think strategically and creatively, adjust to changing circumstances, organize time, remain attentive to details, and identify resources for projects.
- Acute political awareness, insight about the interests and needs of policy makers, and nonpartisan perspective and approach.

Regular domestic travel (1-2 trips per month) for conferences and meetings.
